- Open Meeting
  - Approval of Minutes from previous meeting- Kevin Turner
- Secretary's Report
  - Report out of businesses that have completed their yearly report- William
     King
    - Bills sent out, reporting deadline come and gone. Billed facility amount. Started to receive payment. Facilities that were noncompliant have been notified.
    - Currently have collected 73% of current year balances.
    - Have 71% of reported active facilities completed reports.
  - Report out of Percentage Collected for previous year- William King
    - Forwarded outstanding balances to County Attorney for collections.
    - 16% of overdue accounts collected. Letter in the works from County attorney for collections of overdue balances.
- Finance Committee Reporting
  - Budget Report Chris Saul
    - Cover budget completion and new vehicle purchasing.
    - Fun balance has been built back up to roughly \$126,000 from \$74,000 previous year.
