COMMERICAL LANDFILL USER GUIDE

❖ SAFETY

The Alamance County Landfill staff is dedicated to providing a clean, safe, and hazard-free operation for our customers and the environment. We have approximately 2,000 vehicles passing through our facility on a weekly basis, including citizens in their private vehicles and therefore, we ask that you remind your drivers of the following:

- Loads should be tarped and properly secured.
- Drive slowly/cautiously and follow posted speed limit.
- Follow directions from landfill staff. Be observant and respectful of landfill staff and users, moving heavy equipment and other types of vehicles on the premises.

❖ GENERAL PROCEDURES / RULES:

Alamance County Landfill follows the established rules and regulations per federal, state and local guidelines. Alamance County Landfill may be used only for the disposal of solid waste generated in Alamance County and is not permitted to accept any liquids or hazardous materials. A copy of Alamance County's Solid Waste and Recycling Ordinances along with further information related to the landfill can be found on Alamance County's website. (www.alamancecounty-nc.com)

Alamance County Landfill operates the following permitted areas:

- Municipal Solid Waste (MSW) Landfill
- Construction and Demolition (C&D) Landfill
- Yard Waste Collection Area
- Scrap Tire Collection Area
- White Goods and Scrap Metal Collection Area

The landfill follows a color-coded directional system to assist and guide landfill customers to the appropriate disposal areas. The different disposal areas are identified by a color. Signs labeled with the area along with the appropriate color are established along the roads leading from the scales to the disposal areas. The guide sheet is available at the scales.

Construction & Demolition (C&D) Landfill is limited to the following items listed below. Any loads containing materials other than C&D debris will be diverted to the municipal solid waste landfill and charged according to the MSW rates.

- Brick
- Concrete
- Lumber/Wood
- Shingles
- Sheetrock/Drywall
- Wooden pallets are accepted in the C&D disposal area only.

Yard Waste Collection Area accepts yard waste trash to include clean (no trash, plastic bags, etc.) brush, limbs, stumps, grass and leaves.

Banned Recyclable Materials from the landfill:

- Aluminum Cans
- Antifreeze
- Beverage Containers (ABC Permit Holder)
- Computer Equipment & Televisions
- Corrugated Cardboard
- Glass Bottles & Jars (Clear & Brown)
- Lead Acid Batteries
- Motor Oil Filters
- Newspaper
- Office Paper (commercially generated)
- Oyster Shells
- Plastic Bottles
- Scrap Tires
- Used Oil
- White Goods (Appliances)
- Wooden Pallets
- Yard Trash (Brush)

Per the Alamance County Solid Waste and Recycling Ordinance, any load containing target recyclable materials may be surcharged double the total disposal fee of the load (minimum of \$25.00). Please contact the landfill for questions related to proper disposal of banned recyclable materials.

❖ **SCALE OPERATION / HOURS:**

The landfill scale operator will weigh and inspect incoming loads and direct user to the appropriate disposal areas. Loads can be inspected at any time for potential recycling contaminants, hazardous material and other unacceptable items.

Monday – Friday:	7:00 AM until 4:30 PM
Saturday:	7:00 AM until 12:00 PM
Sunday:	Closed

(Excludes observed holidays)

❖ **TIPPING FEES:**

Tipping fees are charged according the current pricing schedule. Contact the landfill for the current fee schedule.
